

*Preface*

Council House directors falsely claimed that I sent an anonymous updated but unpublished draft to them while I languished in jail. They then had me transferred to solitary confinement with 23-hour lock down as a punishment. I spent 25 days among accused murderers and rapists as part of 111 days that I spent in jail as a result of their campaign to silence me.

Twenty-one directors and managers organized the transfer campaign in a similar way to which they organized the original campaign of character assassination. They perjured themselves and forged documents to make me take down my web site which exposed their criminal activities. Lynn C. W-rtn-k wrote one of those declarations.

Superior Court Judge Anthony P. (Tony) Wartnik (Lynn's husband) then arranged my transfer to solitary confinement *ex parte* (secretly) with Judge Doerty. Doerty issued a *sua sponte* (on a whim without a hearing) order for solitary confinement.

Lynn evidently acts upon the legal advice of her husband. He has committed judicial misconduct by insinuating himself into a case and interceding with a trial court judge in his wife's behalf. [*Judicial Misconduct and the Law*]

Lynn did not provide exhibits to support her claims or psychiatric reports to support her mental health contentions. She made malicious and false accusations that caused punishment without cause. She neglected to realize that jail officers scrutinize all incoming and outgoing mail. They would have prevented the mailing that she claims took place. Jails also insist upon return addresses on all correspondence. [*Rampant Judicial Delusion*]

Her declaration contains innuendo, assumption, and weasel words, that have no place in sworn testimony. This example illustrates the absurdity inherent in all twenty-one declarations that formed part of the campaign to transfer me to solitary confinement. Some declarations they filed retroactively.

Essentially, one person wrote or organized all 21 declarations as part of a campaign to suborn testimony - a pattern or practice that they used to obtain the original 43 perjured declarations.

LCW-02-0611-0000. I am over the age of eighteen and am competent to testify in the matters stated in this declaration and *make these statements on the basis of my personal knowledge.*

I am a past president and current member of the Board of Directors of Council House, Inc. and am entitled to the protections of the antiharassment order entered October 26, 2001 against Paul Trummel.

On or about May 24, 2001 I received via US Mail a copy of an article entitled "Neo-Fascism, Violence, and Queerdom" - Contra Cabal 801-28. The article was sent in an unmarked envelope with no return address.

The article was copyrighted and written by Paul Trummel. Based upon the content of the article, *it appears that* Paul Trummel wrote the article no earlier than May 12, 2002. A copy of the article that I received is attached to this declaration.

*I believe that* Paul Trummel sent this letter to me to further harass and intimidate me. For at least the past two years, Mr . Trummel has written demeaning, threatening and evil messages about the staff, the board and residents at Council House. He has posted my name and address on his website, in his newsletter, *and perhaps more*. Every right has been afforded him by the system, and he continues to waste the energy and financial resources of all those involve. *I believe the man should be given a thorough mental health evaluation.*

I declare under penalty of perjury under the laws of the State of Washington that the foregoing is true and correct.
