

In his letter to Vicki Richman, a journalist colleague, Mitchell trapped himself several times, in particular by admitting that: “[Doerty] denied his petition with prejudice and suggested that I should file a counter suit”. By that, Mitchell confirms the appellant’s contentions that Doerty openly suggested from the bench that Council House prosecute against constitutionally protected speech. He then retained jurisdiction.

Doerty committed gross judicial misconduct by giving advise from the bench. He then reinforced his position by admitting declarations into evidence unquestioned. In fact, he initiated the counterclaim. He has since withheld transcripts and hundreds of other documents from that hearing to cover his tracks. [*Rampant Judicial Delusion*]

Inner Light, the person Mitchell referenced as “a friend who was horrified”, wrote this false and misleading statement after 911. Mitchell acted upon it and used it to perjure himself.

IL-01-1117-1859. . . . The terrorist story is an old one about Simon Rishel etc (and photo in Muslim garb), but I'm sure it wasn't linked from his main page last month, the way it is now. And I think the title might be new? "Tall Structure Terror". Seems a little more than coincidental with last week's events. Why can't the judge make him shut down the website or not put personal information. Seems like that would be justified at this point. Get the lawyers on it . . . Mitchell loses all credibility by claiming that I was “fired from the University of Washington”. I have never worked for that institution. He also had access to my financial records as a tenant and knows that I have never received welfare checks. Moreover, none of the oversight authorities that he mentions have conducted a formal investigation in response to tenant complaints. How could they without supporting documents and interviews with complainants? [*Thespian Liar*]

I wrote to Vicki Richman when she sent me a copy of Mitchell’s message (full text below). I explained to her that many of my colleagues had received similar letters. I told her that Council House had distributed hundreds of rants to support a vicious campaign of vilification, perjury, and subornation to cover up elder abuse and other crimes using kill-the-messenger techniques.

I explained to her that Mitchell intimidated five resident affiants (one now deceased) and tried to bring an action to force me to reveal my sources. Lambert vs. Harris revolves around intimidation of witnesses. I told her that Felipe Jacques, a resident and declared misanthrope, usually sets up strategies with Mitchell and writes his copy and that when Mitchell writes himself he uses stream of consciousness combined with pathological lying. [*Trails of Leon Harris*]

Richman recognized the tactics and correctly typed Mitchell:

“Yeah, that was obvious. He was semi-literate and spreading gossip designed to turn people like me away from you. I have been well familiar with that tactic all my life. It is common for mainstream, nonpolitical, barely educated masses, often a nominal part of a mainstream religion. It is their favorite tactic. Spread *ad hominem* rumors without citing real issues, never confront openly, get disinterested people to shun you. That's what I live with.

My method is to find out what the rumors are, by inference from off-hand comments, and from informants. Then trace them back to the source. That is, there is usually only one liar: everyone else believes it's more or less true. The rumors are generally verbal. Mitchell varied by sending me email which I forwarded to you. He probably won't make that mistake again.

Another tactic of the calumny creator is to accuse the victim of perpetrating what the victim has suffered. It's classic. I know the technique. It's blame-the-victim. It seeks to forestall the victim's self-defense."

I will not bother to go through this rant and refute the points. My lawyers will eventually force Mitchell to admit that he has perjured himself repeatedly by using similar language in sworn testimony. However, it does show how Council House treats its tenants. Mitchell runs blackmail files on many tenants full of similar language to use against them if they dissent.

I present the message here as an example of what Council House directors have distributed to my colleagues and friends. More seriously, Doerty used the information as uncorroborated "evidence". Readers should consider the source. [*Histrionics and Narcissism*]

SAM-01-0919-1204. My name is Stephen Mitchell. I am the administrator of Council House a low income housing facility for seniors in Seattle, WA. I am also the victim of countless attacks from Mr. Paul Trummel.

Most recently I was called by a friend who was horrified. She informed me that Mr. Trummel has posted a photo of me which he has doctored. On the site I have a turban and a beard and I look as if I am a Muslim. He calls the photo Osama Bin Mitchell.

In the article from this man that you support as a "journalist" he lists my home address and that of my staff and suggests that I have ties with terrorist organizations. But he continued on with even more fervor. Yet he screams injustice. I dare say that we are the victims. Sept 11th proved to me that you really have no way of protecting yourself from fanaticism. I only pray that Mr. Trummel does not lose his loose grasp on self control.
